MERITORIOUS *(from \$50,000)*

TRUSTEE (\$700/yr.)

The most prestigious category, providing special benefits in exchange for a higher annual fee. Members can indicate up to 6 representatives.

PATRON (\$450/yr.)

A prestigious category providing a variety of special benefits, in exchange for a higher annual fee. Member can indicate up to 5 representatives.

CORPORATE I (\$275/yr.)

51 & more employees

Member can indicate up to 5 representatives.

CORPORATE II (\$200/yr.)

11 to 50 employees

The most popular. This category is the backbone of the Chamber. Member can indicate up to 3 representatives.

SMALL BUSINESS (\$125/yr.)

1 to 10 employees

Serves as a way to get acquainted with the benefits of the Chamber. Member can indicate just 1 representative.
